Case Study: China / Japan Corporate Patent Dispute Filed In United

Chinese electronics manufacturer was engaged in a patent dispute with a Japanese company filed in U.S. patent court. Consilio executed rolling on-site collections, including laptops, mobile devices with WeChat extraction and server data, processed and hosted the data in mainland China. Then after facilitating an in-country managed document review (including China state secrets review), the cleared data was then sent to the United States for production.

Case Study: Global Medical Device Fcpa Investigation

Global manufacturer of medical devices faced a wide-ranging FCPA investigation requiring a multi-jurisdictional collection across APAC, including mainland China. Data was processed and hosted within specified country borders and first level managed review conducted in Tokyo, Hong Kong and Shanghai.

Case Study: International Cartel Investigation

Faced with a large U.S. Department of Justice investigation, the end client--unfamiliar with the U.S. eDiscovery process--relied on Consilio expertise to educate and advise them throughout the entire EDRM spectrum; ultimately involving terabytes of data collected from over 50 custodians across Tokyo, Nagoya, and Osaka.

在美涉诉的中国/日本公司专利纠纷

一家中国电子产品制造商卷入一起由一家日本公司在美国专利法院提起的诉讼。Consilio执行了定期现场数据收集，包括笔记本电脑、内含微信提取信息和服务器数据的移动设备，并在中国大陆处理和托管数据。在推进国内管理的文件审查（包括中国国家机密审查）之后，将所需未涉密的数据送往美国进行处理。

全球医疗器械FCPA调查

某全球医疗器械制造商面临一起大范围的FCPA调查，需要在包括中国大陆在内的亚太地区进行多管辖区域的数据收集。相关数据在指定的国家领域内进行处理和托管，并在东京，香港和上海进行初步审查。

国际卡特尔调查
