The General Data Protection Regulation (GDPR) (EU) 2016/679 is an EU regulation on data protection and privacy, protecting all individuals within the European Union (EU). The regulation seeks to bring more transparency to people about what data organisations collect about them, what they use it for, who they share it with, and also provides individuals with more rights, including the right to request that companies reveal or delete the personal data they hold.

GDPR applies to all organisations within the EU and to those located outside of the EU **if they offer goods or services to, or monitor the behavior of**, EU data subjects. The Regulator's enforcement actions are significantly larger than previous Regulations, with the maximum fine now reaching the higher of €20m (£17.5m) or 4% of the company's global turnover.
